Founded in 1973, Friends of Homeless Animals (FOHA), Loudoun County's largest no-kill dog and cat rescue, will be hosting "Barktoberfest: A Purrfect Pet Celebration" on Saturday, September 23, 2017 at the Loudoun County Fairgrounds. This event will celebrate the human-animal bond while raising awareness and funds to benefit the hundreds of adoptable animals cared for by FOHA.

The celebration will feature live music, vendors and artisans, interactive games for pets and children, an animal communicator, a kitty corner for cat lovers, canine demonstrations, a silent auction, raffle items, contests, food vendors, wine tastings, the Glow DOG Glow run/walk and more. Food Vendor Contract

This Food Vendor Contract is made as of _____ 2017, between _____ ("Vendor"), of _____, and Friends of Homeless Animals, Inc. ("FOHA"), a Virginia corporation.

WHEREAS, FOHA wishes to permit Vendor to sell food and non-alcoholic beverages at the BarktoberFest ("the event"), to be held September 23, 2017 at the Loudoun County Fairgrounds, and Vendor is prepared to deliver such services, the parties agree to the following terms and conditions:

1. Vendor shall be obligated to set-up for the event at 10 a.m. on September 23, 2017 in the designated outdoor area at the Loudoun County Fairgrounds, and shall furnish all equipment, tables and chairs it requires for the provision of its services.
2. Vendor shall be entitled to sell any food and non-alcoholic beverage it chooses. You are not permitted to sell alcohol at Barktoberfest unless you are a pre-approved vineyard or brewery.
3. Vendor shall be provided access to electricity and water without charge, but shall provide its own extension cords and hoses to connect with such utilities.
4. Vendor shall obtain whatever federal, state, or Loudoun County permits are required to enable it to provide its services at the event.
5. Vendor agrees that in performing the services permitted by this agreement, it will be acting as an independent contractor and not as an employee of FOHA, and shall be responsible, at its own expense, for providing any accident or medical insurance.
6. Vendor shall remit no less than \$150 prior to the event or may choose to remit 15% of its gross revenue derived from sales at the conclusion of the event. Please check and initial the appropriate box: _____ My check is enclosed/credit card # is provided as I choose to pay prior to the event. _____ I opt to pay 15% of gross sales at the conclusion of the event on 9/23/17.
7. Vendor understands that should it fail to abide by any applicable federal, state, or local law or ordinance, or should it act in a manner considered by FOHA to be detrimental to the organization or to detract from the event, FOHA shall have the right immediately to terminate Vendor's participation in the event without prior notice.
8. Vendor hereby agrees to release, indemnify, and hold harmless FOHA, and its officers, agents and employees from any and all liability, damage, and claims arising out of the acts or omissions of Vendor at the event.
9. Neither party may assign or transfer this contract without the prior written consent of the other party.

10. This contract may only be modified or amended in writing, signed by both parties.
11. The failure of either party to enforce any provision of this contract shall not be construed as a waiver or limitation of that party's right to subsequently enforce and compel strict compliance with any provision of this contract.
12. This contract shall be governed by the laws of the State of Virginia.

IN WITNESS WHEREOF, the parties hereto have executed this contract by their duly authorized representatives on the date first set forth hereinabove.
